*Robert Dodding attended the Leet Court 24 times between 1712 and 1742. In 1714 he was elected Pinder of Hog-ringer. He was Mayor 5 times, in 1735, 37, 39 41 and 43. He must have died in office. He was a Walpole man and succeeded John Haton. He was followed by John Wakefield, Castle Rising's longest serving Mayor. **William** Dodding, who was probably his father had been Mayor of the town in 1695, 1697, 1700, 1702 and 1704. He had been involved in the events associated with the Walpole/Howard electoral pact, and seems to have been nominated by Thomas Howard. It seems therefore that the Doddings were a family who had affinities to both the Howards and the Walpoles. **William** died in 1708 and was described as a clerk. **Henry** Dodding attended the Leet Court regularly from 1719 to 1742 and on several occasions was a constable for the town. **Thomas** Dodding attended the Leet Court from 1705 until 1719. He was Constable on several occasions. **Robert Dodding junior** the second son of Robert and Marie Dodding, attended the Leet Court in 1735 at the age of 20, and was elected both Sergeant-at-Mace and Constable. It was a custom in the town to appoint the sons of Mayors to be Sergeants-at-Mace. It was his only appearance; he died soon after in 1738 at the age of 23. Robert's eldest son **William** attended the Leet Court in 1738 at the age of 24, after the death of his brother and he also was elected Sergeant-at-Mace. He continued to attend until 1742. This*

was the last year in which a member of the Dodding family had any connection with the Leet Court.

Unfortunately the records of baptisms, marriages and deaths for the period of the late 17th century are missing but it seems likely that **William** Dodding, the first of that name to be found in the Leet Court, was the father of **Robert**, **Thomas** and **Henry**. All three of these men were married, although we have no records of the marriages. **Robert** was married to Marie; **Thomas** was married first to Mary, who died in 1710 and then by 1715 to Elizabeth. **Henry** was married to Mary. All three brothers and their wives were producing children in the first half of the 18th century. **Robert** and **Marie** had 2 sons, William and Robert, and a daughter, Mary. Robert's wife, Marie (or Marina) died in 1720. **Thomas** had two sons Henry and William with **Mary** and with his second wife **Elizabeth** they had 4 sons none of whom lived more than a few years. **Henry** was married to **Mary** and they had 9 children between 1722 and 1736. **Thomas**, who was a warrener, died in 1722 and Elizabeth in 1741. **Robert**, whose inventory is above died in 1743. We have no record of **Henry**'s death.

The only member of the family from the third generation to play a known part in the life of the village is **William** Dodding, the probable grandson of the original William Dodding.

Clemence Dodding, who witnessed the inventory is recorded as having married Henry Goodson of Castle Rising in 1744. She may have been a niece of Robert but there is no evidence of a birth under that name.
